Ontario Continues to Support Municipalities through the Ontario Municipal Partnership Fund

TORONTO — Ontario is continuing to support northern, rural and small municipalities through the Ontario Municipal Partnership Fund (OMPF), which will once again provide funding of \$500 million for 2024. The funding, which is unconditional, will be distributed to 390 municipalities across the province to help local priorities and specific community needs.

"Maintaining a close relationship with our municipal partners is critical as we build a strong Ontario together," said Peter Bethlenfalvy, Minister of Finance. "Our government recognizes the unique challenges northern, rural and small communities face. This is why the Ontario Municipal Partnership Fund, along with other programs, are critical in building stronger and resilient communities across the province."

The OMPF is one part of Ontario's overall support to municipalities, which continues to increase. The government has doubled the Ontario Community Infrastructure Fund (OCIF) and, since 2021, has introduced new supports such as the Northern Ontario Resource Development Support (NORDS) and the Building Faster Fund, a \$1.2 billion program that supports community growth throughout the province, including in small, rural and northern communities. Ontario also recently announced that it will restore provincial annual base funding for public health units in 2024.

"As municipalities begin annual budget planning this fall, ongoing economic uncertainty threatens their ability to make informed decisions for the long-term," said AMO President Colin Best. "Stable and predictable funding like the Ontario Municipal Partnership Fund remains critical to municipal governments who remain key partners in helping to build a strong Ontario."

Announcing municipal allocations in the fall provides municipalities with predictability ahead of their annual budget planning cycle.

Quick Facts

- The OMPF is providing \$500 million to 390 of Ontario's 444 municipalities in 2024. The funding is unconditional and can be used to support the local priorities and specific needs of each community.
- Ontario increased its annual investment in the Ontario Community Infrastructure Fund (OCIF) by \$1 billion over five years, starting in 2022. OCIF provides investment to help 425 small, rural and northern communities renew and rehabilitate roads, bridges, water and wastewater infrastructure.
- The Northern Ontario Resource Development Support (NORDS) program is providing up to \$15 million annually over five years to northern municipalities to support infrastructure projects.
- Starting January 1, 2024, the Province will restore annual base funding (\$47 million) for public health units to the level previously provided under the 2020 cost-share ratio.
- The Building Faster Fund will provide up to \$1.2 billion over three years for municipalities that meet or exceed the housing targets they have pledged to achieve by 2031.

Application for Zoning By-law Amendment and Plan of Subdivision

Property Location: Plan 16M8 Part of Block 1

What is being proposed?

The proposal involves the development of a Draft Plan of Subdivision to create 58 residential lots, 2 parks, and 2 servicing blocks. The proposed zoning by-law amendment would rezone the subject property from Development 'D' zone to Residential One 'R1-3-XX', Residential Two 'R2-XX', and Open Space 'OS' to permit 45 single detached dwellings and 13 rowhouses. The dwellings are proposed to connect to municipal water and wastewater services. The proposal includes the extension of West Ridge Drive, the construction of a new road, and multiple links to the Georgian Trail. The subject property is currently vacant.

Property Location: 107 Martin Grove (Plan 950 Lot 54)

What is being proposed?

The proposal is to create an exception in Zoning By-law 2018-65, as amended, to permit the use of the existing single detached dwelling as a Bed and Breakfast. The subject lands are currently zoned Residential One 'R1-1'. The existing dwelling contains 4 bedrooms, 3 of which will be used as guest rooms and the remaining one by the owner. This proposal is also subject to Site Plan Control. The effect of the application is to rezone the portion of the subject lands zoned Residential one 'R1-1' to Residential One 'R1-1-9' zone.

What is being proposed?

At the July 10, 2023 Council meeting, Council received a formal request from The Blue Mountains Public Library to rename the Craigleith Depot to the "Craigleith Station".

At the August 28, 2023 Council meeting, Council directed staff to schedule a Public Meeting on October 31, 2023 to receive comments regarding the potential renaming of the Craigleith Depot.

Staff will provide a follow up staff report to the November 27, 2023 Committee of the Whole meeting that will summarize the public comments received and provide recommendations for Council to consider at the December 11, 2023 Council meeting.

Lakewood Drive Reconstruction





The Town of The Blue Mountains has identified Lakewood Drive for reconstruction due to deficiencies with the water distribution and sewage collection systems. The subdivision was constructed in 1971, and is now due for replacement of the inground works. The road will be reconstructed and the ditches reshaped and cleared of trees.

The reconstruction project will include:

- Replacement of the sanitary collection system, mains, structures, and laterals to
 property line. The Town notes that some properties have seen adjustments that
 have changed the widths of some lots. If laterals are no longer within the frontage,
 the property owner will have to construct a new building drain to a new lateral
 location.
- Replacement of the water distribution system, mains, valve, and laterals. The sub-standard 75mm main will be replaced with a 150mm main which will allow hydrants to be installed providing an increased level of service to the residents.
- Reconstruction to match the Town's rural road cross-section, with some adaptions where ditches or drainage outlets are missing. Minor alterations of the existing drainage pattern may be incorporated into the work if endorsed by residents.
- The residents may elect to have the level of service increased with respect to drainage as outlined in the Stormwater Study. If these works go forward, the road and ditch design would be modified.

At the request of the residents of Lakewood Drive and the Shore Acres Property Owners Association (SAPOA), Tatham Engineering Limited has completed a Stormwater Study for the Lakewood Drive Reconstruction project area. The study has identified existing drainage deficiencies along Lakewood Drive and through the adjacent private properties, and has provided recommended solutions to address these deficiencies. These solutions will be reviewed and discussed during this Public Information Centre.

Ontario Winding Back Changes to Official Plans

Paul Calandra, Minister of Municipal Affairs and Housing, released the following statement:

"Since becoming Minister of Municipal Affairs and Housing, I have made it a priority to review past decisions, including minister's zoning orders and official plans, to ensure that they support our goal of building at least 1.5 million homes in a manner that maintains and reinforces public trust.

In reviewing how decisions were made regarding official plans, it is now clear that they failed to meet this test. In response, as soon as I am able, I will be introducing legislation that would reverse the official plan decisions for Barrie, Belleville, Guelph, Hamilton, Ottawa and the City of Peterborough, the Regional Municipalities of Halton, Niagara, Peel, Waterloo and York, as well as Wellington County. This legislation would wind back provincial changes to official plans and official plan amendments, except in circumstances where construction has begun or where would contravene doing SO existing provincial legislation and regulation. This includes winding back changes to urban boundaries.

To ensure that the reset plans match our shared ambitions to build more homes, especially now that municipalities have made their housing pledges, we will be asking impacted municipalities to submit changes and updates to those plans to ministry staff within 45 days of today, including information on projects that are already underway.

In recognition of the costs incurred by municipalities arising out of this decision, the province will work with impacted municipalities to assist with related planning and staffing costs."

Yard waste will be collected on your regular curbside collection day and must be curbside by 7:00 a.m. Residents are limited to 10 compostable bags or containers per week.


Excess or oversized leaf and yard waste can be dropped off freeof-charge to the Town's Landfill and Recycling Depot anytime during regular operating hours.

Ontario Building More Electric Vehicle Charging Stations

PORT HOPE — The Ontario government is providing more funding to build thousands of new electric vehicle charging stations in small and medium-sized communities, making it easier and more convenient to charge up outside of large urban centres and giving drivers the confidence they need to transition to electric vehicles.

"Building more public charging stations is part of our government's plan to be a global leader in the electric vehicle industry and provide more travel options for commuters," said Prabmeet Sarkaria, Minister of Transportation. "The EV ChargeON program will help get more electric vehicles on the road by building the infrastructure needed to support them, while securing a better future for Ontario."

Starting today, the province is accepting applications for the EV ChargeON program to build publicly accessible charging stations in communities with less than 170,000 people, as well as in any Indigenous community in Ontario. Eligible applicants include businesses, not-for-profit corporations, municipalities, Indigenous businesses, organizations and communities, and broader public

sector organizations like hospitals and universities.

"Our government is paving the way towards an electric future by building the infrastructure needed to support the electrification of transportation across Ontario," said Todd Smith, Minister of Energy. "This program will deliver thousands of chargers across the province, which will be powered by our reliable, affordable and clean electricity grid, making EV travel for businesses and families easier than ever."

The province's \$91 million investment in the EV ChargeON program will also help build more EV chargers on government-owned land, including Ontario's highway rest areas, carpool parking lots and tourist destinations such as Ontario Parks.

Ontario's EV ChargeON program builds on the government's broader efforts to make it easier to access electric vehicle chargers across the province. This includes supporting Ontario's Ivy Charging Network, which represents the largest public highway fast charging network in the province, with charging stations installed at all 20 renovated ONroute stations along the province's busiest highways, the 400 and 401.

Quick Facts

- The EV ChargeON program consists of two streams: the Community Sites Stream and the Government Sites Stream. Applications for the EV ChargeON Community Sites Stream, a competitive grant subsidy program, are now open for eligible private and public sector entities. Eligible applicants have until January 31, 2024, to submit their application.
- As of September 2023, there were more than 135,000 EVs registered in Ontario, including both battery-electric vehicles (BEV) and plugin hybrid electric vehicles (PHEV). By 2030, over one million EVs are expected on Ontario's roads.
- As of September 2023, there are over 2,900 public charging stations with 7,900 ports (or outlets) in Ontario. These include 6,600 Level 2 ports and 1,300 Level 3 fast-charging ports.
- Drivers can reduce their greenhouse gas emissions by 60-90% by driving battery-electric vehicles or plug-in hybrid electric vehicles and using Ontario's low-carbon electricity to power their vehicles.
- This initiative supports the government's Driving Prosperity: The Future of Ontario's Automotive Sector plan to create a domestic EV battery ecosystem in the province and position Ontario as a North American automotive innovation hub.


