Official Plan Phase 2 Recommendation Papers Posted, Public Meeting and Open House Scheduled

The Town of The Blue Mountains would like to advise residents that the Recommendation Papers for Phase 2 of the Official Plan Review have been posted to the project webpage. In addition, the Statutory Public Meeting and Statutory Open House have been scheduled for this Fall to provide public engagement and comment opportunities.

The Recommendation Papers summarize the proposed changes to the Official Plan by theme. Town Staff and the project consultants determined each recommendation after considering comments received through the public engagement process.

There are seven Recommendation Papers:

- Sustainability, Parks and Open Space
- Housing Mix and Affordability
- Infrastructure and Servicing
- Intensification and Density
- Commercial and Employment
- Agriculture and Rural Lands
- Transportation

The Statutory Public Open House is scheduled for **Monday**, **September 23**, **2024**, with the Statutory Public Meeting scheduled for **Tuesday**, **October 1**, **2024**.

The complete draft of the Official Plan with proposed changes will be shared to the project webpage in early September to allow public review before these meetings.

Grey County Municipalities Exploring Shared Services Model For Planning

On Thursday, August 8, all nine Grey County member municipalities met to discuss a potential shared services model for the delivery of planning services. The proposed service model would see local planning staff join a reorganized Grey County planning department. Local municipal decision-making authority would be unchanged and operational efficiencies would be expected at the administrative level.

Grey County and local municipal councils are reviewing the shared-service model for a few reasons. There have been several changes to provincial planning legislation changes in recent years. Staff have been engaging with developers and collecting feedback to understand their needs and challenges. Grey County and local municipalities have an ongoing goal of optimizing service delivery for all parties involved in supporting the development of new homes and new or expanded businesses.

Over the coming months, local councils and staff will discuss the challenges and opportunities of a shared services model. An evaluation report is expected to be considered by Grey County Council and local municipal councils before the end of the year.

Grey County's nine member municipalities are the Township of Georgian Bluffs, the City of Owen Sound, the Municipality of Meaford, the Town of The Blue Mountains, the Township of Chatsworth, the Municipality of Grey Highlands, the Municipality of West Grey, the Town of Hanover and the Township of Southgate.

Eligible non-profits may request up to \$3,000 to support their local projects. In fall 2023, 30 charitable organizations were granted over \$66,000 for projects including accessible recreation opportunities for youth, environmental initiatives, local festivals, and food security efforts. The Foundation also has a spring intake period for Community Grants that supported 52 requests with over \$128,000 in funds this year.

Rural Municipal Leaders Support 'Solve the Crisis' Campaign to Address Homelessness and Mental Health

Representing 230 municipalities and over 2.6 million people across Ontario, the Western Ontario Wardens' Caucus, Eastern Ontario Wardens' Caucus, , and Eastern Ontario Mayors' Caucus join the call to action around the 'Solve the Crisis' Campaign, led by the Ontario Big City Mayors.

During their joint meeting at the start of the Association of Municipalities of Ontario (AMO) 125th Conference, the three caucuses are stating their collective support around the need for the Ontario and Federal Governments to take immediate and targeted action to help solve the crisis around homelessness and mental health.

There is a homelessness and mental health crisis happening on streets across our communities, small and big, rural and urban. Municipalities continue to step up, but do not have the tools, expertise or capacity to fully address the intersectional and complex issues around housing, homelessness, health care, and social services.

We appreciate the actions that both the Federal and Ontario Governments have taken to-date including Ontario's Roadmap to Wellness, the creation of the Homelessness Prevention Program, and investing in youth wellness hubs.

But we need to do more to 'Solve the Crisis' together as government partners, and we need to act swiftly.

As municipalities continue to raise, the rising number of homeless encampments and the human toll of the opioid crisis are a symptom of deeper system failures that hurt Ontario's overall social and economic prosperity. The WOWC, EOMC, and EOWC will be sending a letter to Premier Ford to further underscore the need for a Social and Economic Prosperity Review. We need a municipal fiscal relationship that supports the foundations of a strong economy, sustainable communities and quality of life that reflects modern day and frontline realities.

Town to Begin 2024 Road Surface Treatment Work

Maintenance / Service Disruptions June 21, 2024


The Town of The Blue Mountains would like to advise the public that surface treatment road work will be conducted on various rural and urban roads beginning in late July. Partial lane closures will be in effect during construction. Work is anticipated to be completed by mid-August.

Road surface treatment will occur on:

- Pretty River Road
- 10th Line between Grey Road 13 and 9th Sideroad
- 10th Line between Russell Street and 30th Sideroad
- 30th Sideroad between 10th Line and The Blue Mountains - Meaford Townline
- The Blue Mountains Meaford Townline between Highway 26 and 30th Sideroad
- 33rd Sideroad between Duncan Street and The Blue Mountains - Meaford Townline

Residents are asked to reduce speeds on roads that have recently been treated to help lessen the disturbance of the roadway.

The Town utilizes surface treatment paving on many rural roads with low to medium traffic volumes as a more cost-effective and durable alternative to asphalt concrete paving. The maintenance of surface-treated roads occurs every 5-7 years between May and September.

What is Tar and Chip?

Tar and chip roads look similar to asphalt concrete roads but have some differences. Both pavement surfaces use asphalt cement bitumen (Tar) and Aggregates (Chip). Asphalt concrete road surfaces are mixed in a central plant and shipped to the road site hot and mixed for paving. This type of paving is cost prohibitive for smaller rural municipalities such as The Blue Mountains. "Tar and Chip" pavement involves evenly applying hot asphalt cement tar onto a roadway, followed by an even layer of angular aggregate stones which is rolled into place. The stones are further compacted and pushed into the asphalt cement tar over time by the traffic on the roadway. As a result for a period of weeks or months following the application of Tar and Chip to a roadway, there is some loose crushed stone on top of the road surface. The road will eventually resemble the asphalt concrete roads in higher traffic areas after a period of time dependent on the heat of summer and the volume of traffic.

What can you expect?

On roads that have been previously treated, one layer of tar and chip will be applied (single surface treatment). Roads which are being newly paved will receive two successive layers of tar and chip (double surface treatment). Town road maintenance staff may sweep the road several weeks or months following the initial application of tar and chip to reduce the loose stone. The brief periods of inconvenience will be followed by a road surface similar to an asphalt concrete road for periods of 5-7 years.

What can you do?


When your road has been recently paved using tar and chip technology, residents are requested to not sweep the road during the period when the chip is loose, as sweeping may result in a poor wearing surface and an unsafe road condition. The most helpful thing you can do is reduce your vehicle's speed. This will help to reduce the disturbance of stone on the roadway to ensure a clean even surface as well as minimizing dust from the road. Be a good neighbour – slow down.

Construction Notice - Monterra Road -Beginning July 2024

Maintenance / Service Disruptions Public Notices July 12, 2024



The Town of The Blue Mountains would like to advise the public of upcoming construction activity on Monterra Road in Craigleith from Grey Road 19 to 200 metres east of Grand Cypress Lane.

Cox Construction Limited will be will be resurfacing approximately 875 metres of Monterra Road. Work will include a new 7 metre wide road surface and a 1.2 metre wide paved shoulder on the north side of the road for a portion of the road section. Sewer maintenance holes and valve chamber chimneys will be rebuilt and guide rail cable posts will be replaced along with other miscellaneous work.

This work is expected to be ongoing until mid to late August 2024. Monterra Road will remain open, but alternating one-way traffic controlled by flaggers will be in place at times.

The establishment of new telecommunication facilities is under the exclusive jurisdiction of the Federal Government. The Town of The Blue Mountains Protocol for Establishing Telecommunication Facilities requires public consultation for all new telecommunication facilities.

Notice – Announcing the OPP Detachment Board

The Town of The Blue Mountains is pleased to announce that The Blue Mountains Police Services Board has formally transitioned to The Blue Mountains OPP Detachment Board.

In March 2019, the Ontario government passed the Community Safety and Policing Act, 2019 ("CSPA") as part of the Comprehensive Ontario Policy Services Act, 2019. The CSPA came into effect on April 1, 2024 and replaced the Police Services Act, 1990.

Under the new legislation, The Blue Mountains OPP Detachment Board will have a more clearly defined and expanded role in the community. The Board has undertaken a number of steps to ensure compliance with the legislation and applicable regulations. Details outlining these changes can be found in staff report FAF.24.071 Update to Council regarding the Community Safety and Policing Act, 2019 and Impacts to The Blue Mountains Police Services Board as presented at the Special Committee of the Whole Meeting on June 17, 2024.

Across the Province, OPP Detachment Boards provide civilian input about how policing is provided in their local communities by the OPP. The Blue Mountains OPP Detachment Board is a civilian body that oversees the Collingwood OPP Detachment and The Blue Mountains Satellite Office. The roles and responsibilities of OPP Detachment Boards are set out under Section 68(1) of the CSPA:

 Consult with the Commissioner regarding the selection of a Detachment Commander and otherwise participate, in accordance with the regulations made by the Minister, in the selection of the Detachment Commander;

- Determine objectives and priorities for the Detachment, not inconsistent with the Strategic Plan prepared by the Minister, after consultation with the Detachment Commander or his or her designate;
- Advise the Detachment Commander with respect to policing provided by the Detachment;
- Monitor the performance of the Detachment Commander;
- Review the reports from the Detachment Commander regarding policing provided by the Detachment;
- On or before June 30 of each year, provide an annual report to the Town of The Blue Mountains Council regarding the policing provided by the Detachment in their municipalities.

The Board is comprised of five members appointed for the term of Council, including two Council Appointees (one being the Mayor), two Public Appointees, and one Provincial Appointee. The current Board composition is:

- Councillor Gail Ardiel
- Jim Oliver, Public Appointee and current Chair
- Lynn Church, Public Appointee and current Vice-Chair
- Donna Wilson, Provincial Appointee

Staff Resources include Detachment Commander Loris Licharson, Chief Administrative Officer Shawn Everitt and Deputy Clerk/Recording Secretary Kyra Dunlop.

Ontario Investing \$400 Million in Roads and Bridges to Enable More Homes

Provincial funding will help municipalities build and repair local infrastructure

Beginning August 21, the Ontario government will be accepting applications for funding under the \$400 million Housing-Enabling Core Servicing stream of the \$1 billion Municipal Housing Infrastructure Program to build, maintain, and repair core assets such as municipal roads, bridges and culverts that will support the construction of new homes. Of the \$400 million, the government is allocating another \$120 million to projects in small, rural and northern municipalities that do not have housing targets to better support the unique needs of these growing communities.

"Our government is working with our municipal partners to support their infrastructure needs and get more homes built across the province," said Kinga Surma, Minister of Infrastructure. "This investment, in addition to the \$970 million we are investing in water infrastructure through the first intake of the Housing-Enabling Water Systems Fund, will help unlock more housing opportunities beyond 511,000 homes, bringing us another step forward in our historic partnership with municipalities to build the infrastructure and homes that our communities need to grow and prosper."

Municipalities will be able to submit applications for the Housing-Enabling Core Servicing stream starting tomorrow. Eligible projects include any road and bridge assets that enable housing infrastructure and promote growth in communities. These projects must be a net new, rehabilitation, repair, reconstruction or replacement project. More information about the program and how to apply is available at ontario.ca/housinginfrastructure.

The remaining funding under the Municipal Housing Infrastructure Program will help municipalities target other key infrastructure priorities, including maintaining the health and safety of local water and wastewater systems. More information about this funding, including eligibility and application intake details, will be announced later this year.

Earlier this month, Ontario also announced the launch of a second intake of applications under the \$1.2-billion Housing-Enabling Water Systems Fund. Combined, the Municipal Housing Infrastructure Program and the Housing-Enabling Water Systems Fund are providing municipalities with more than \$1.9 billion in provincial funding for housing- and community-enabling infrastructure, as part of the province's capital plan of over \$190 billion to build critical infrastructure and support growing communities.

Quick Facts

- Under the first intake of the Housing-Enabling Water Systems Fund, the government is investing \$970 million in 54 water infrastructure projects that will enable over 500,000 new housing units in 60 municipalities across the province.
- Applications for the second intake of funding for the Housing-Enabling Water Systems Fund close on November 1st. Details about the second application intake and eligibility can be found at ontario.ca/watersystemsfund.
- Municipalities with assigned housing targets are receiving a total of \$262 million from the Building Faster Fund for 2023 performance against housing targets.
- Ontario is also providing municipalities improved and flexible borrowing terms for housing-enabling water projects under Infrastructure Ontario's loan program. This new lending stream would build on the valued financing Infrastructure Ontario already provides to many municipal partners and would provide them with options for deferred interest payments until projects are substantially complete, longer loan terms, more flexible repayment terms, and lower administration costs.




