



Ontario Offering Free Fishing on Father's Day Weekend - June 15-16

In honour of Father's Day on Sunday, the province is offering free fishing this weekend.

"Father's Day weekend is a great time to get out on one of Ontario's beautiful lakes or rivers and enjoy fishing," said Graydon Smith, Minister of Natural Resources. "Fishing is a fun activity for everyone in the family and it's a great way to spend time together, so I encourage you to cast a line June 15 and 16 to celebrate Father's Day."

Right now, you can fish for many species, including yellow perch, common carp, northern pike, lake trout and walleye in most of Ontario. Some waterbodies have exceptions; be sure to check the Fishing Regulations Summary before heading out so you are aware of all limits on how many fish you can keep.

If you are fishing for free during this period, you need to carry identification issued by the provincial or federal government, showing your name and date of birth.

Quick Facts

- Over one million licensed anglers spend \$1.75 billion per year on recreational fishing in Ontario.
- The last annual free fishing event this year is Family Fishing Week (June 29-July 7) to celebrate Canada Day.
- Ontario fishing licences can be purchased online at huntandfishontario.com. If buying online, always look for the Ontario logo. You can also purchase in person at participating ServiceOntario or authorized licence issuer locations.
- Outside of free fishing periods, most Canadians between the ages of 18 and 65 must have an Outdoors Card and a fishing licence.
- Veterans and active Canadian Armed Forces members residing in Ontario can enjoy free recreational fishing in the province all year.

Town Seeking Consultant for New Fire Hall in Craigleith

The Town of The Blue Mountains would like to advise residents that a Request for Proposals (RFP) process is currently underway seeking a consultant to support the design and construction of the New Craigleith Fire Hall #2. The deadline for completed RFPs was May 30, 2024. Award of the contract is expected in late June or early July. Details can be found through the Town's Purchasing & Bid Opportunities web page. The design and engineering work for the new facility is expected to be completed within Q1 of 2025, with construction anticipated to span from Q1 of 2026 to Q1 of 2027.

The existing Craigleith Fire Hall located at 796338 Grey Road 19 was originally built in 1989. Through the Town's Fire Master Planning process, it has been found that the current facility will be unable to continue meeting the needs of its service area. The new facility will be built at the former Board of Education property south of 796511 Grey Road 19. The new fire hall will be built to better serve and meet the needs of the expanding population and growth in tourism activity within the Craigleith area. The existing fire hall building is planned to be retrofitted as a satellite operations centre to support the Town's Parks and Trails, and Roads and Drainage Divisions. The Town is also looking at opportunities to incorporate touch-down workspaces for Town staff to use in the Craigleith area.

"This new fire hall represents a huge step for us as a service," said Fire Chief Steve Conn. "It will ensure our firefighters have the appropriate facilities to continue the critical work they do protecting the Town's residents and visitors."

\$13.3 Million in funding for the project was approved through the 2024 Town Budget. Funding sources include the Community Services Asset Replacement Reserve Fund, Roads Equipment Asset Replacement Reserve Fund, Fire Asset Replacement Reserve Fund and Fire Development Charges.

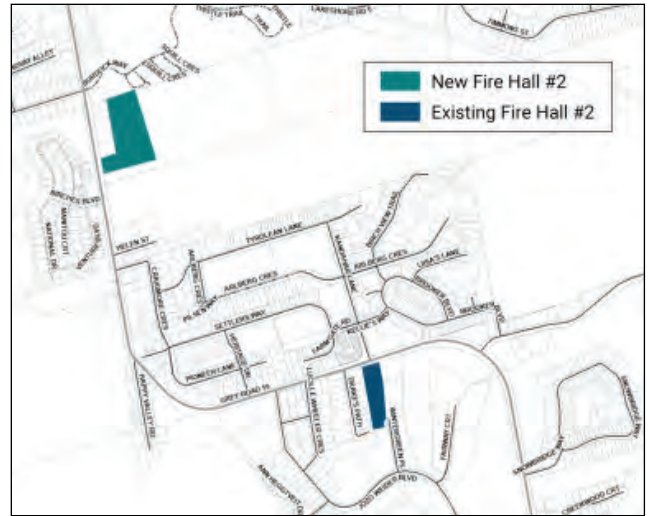
Project Background

In early 2021, Town Staff identified the former Board of Education property south of 796511 Grey Road 19 as a potential location for a future town facility. Initial notice was provided to surrounding property owners in June of 2021, and a staff report (FAF.21.106) was brought to Council at that time seeking endorsement, in principle, of pursuing this plan. Over the next two years, staff found that the best use for the property would be an enhanced and larger Fire Hall to replace the existing Craigleith Fire Hall.

Update to the Canada Dental Care Program (CDCP)

A lot of people are worried about finding an oral health care provider (e.g. Dentist, denturist, hygienist, etc.) who is signed up for the CDCP which is being run by Sun Life.

The federal government has made it easier for patients and dental care providers. As of July 8th, oral health providers will be able to direct bill Sun Life for services provided on a claim by claim basis without formally signing up for CDCP.

This means that if you are an approved CDCP client, (you have your card & membership number) you can see any oral health care provider and have your services covered as long as the provider agrees to direct Sun Life for the services under the plan. The provider may also charge more for the services than the plan pays which means that you might have to pay some part of the fee for services.

The Blue Mountains Attainable Housing Corporation

From a report by Shawn Everitt, President/Chair to be presented at the Council Committee of the Whole Meeting on Monday, June 17th

Since the Town took on the temporary management of The Blue Mountains Attainable Housing Corporation (BMAHC), following direction at a special meeting of Council held, November 30, 2023, valuable information and input from individuals who have firsthand perspectives and real-life experiences with the challenges of obtaining housing and accommodation have been discussed.

The Board of The Blue Mountains Attainable Housing Corporation (BMAHC) currently with members of staff have met a total of six (6) times as of June 6th and have discussed a variety of housing topics.

If Council approves the recommendation to request the current Board members to draft a Terms of Reference for a potential Attainable Housing Committee of Council, the Board suggests that as part of that Terms of Reference the need to provide opportunity and ease of membership to those individuals that live with the real challenges of finding and maintaining attainable living in our community and region to ensure that perspective is always present and front facing.

If Council wishes to continue the operations and business of The Blue Mountain Attainable Housing Corporation (BMAHC), a significant amount of work relating to the updating of the Corporate By-laws, Policies, and Financial Strategy will be required. At this point, there are no existing staff with capacity within their 2024 work plan to take on these activities.

The Town continues to look to Grey County to bring forth a recommendation to County Council that provides a strategy of how best to proceed with a Regional Housing Needs Strategy. This work has been driven by the motion that the Town of The Blue Mountains' Council put forth to Grey County for their consideration of a Regional Approach.

The Board of The Blue Mountains Attainable Housing Corporation recommend the following:

1. that The Blue Mountains Attainable Housing Corporation request that Council of the Town of The Blue Mountains direct staff to initiate the formal process of dissolving The Blue Mountains Attainable Housing Corporation at the estimated cost of \$30,000 and with full dissolution to be completed no later than December 1, 2024;
2. and that the Council of the Town of The Blue Mountains request the members of The Blue Mountains Attainable Housing Corporation to bring forward a draft Terms of Reference that would provide the basis for the scope and mandate for the potential establishment of a formal Attainable Housing Committee of Council;
3. and that the Council of the Town of The Blue Mountains engage with the TBM Housing Strategy Working Group to consider how best to collaborate on the Attainable Housing Portfolio.

Over the past couple of months, the TBM Housing Strategy Working Group, has been established and is currently made up of the following volunteer members: Jim Torrence, Pamela Spence, Roslyn Morrison, Russell Higgins, Natalia Skoko, Janet Findlay, Former BMAHC member, and Gavin Leitch, Former BMAHC member.

The suggestion of the internalization of the Attainable Housing portfolio would be a strong move to ensure that the Town is well-informed and better positioned to aid in enhancing the range of housing stock that is supported by strong and innovative policies.

This shift would also allow Council to control the funding and spending for the Attainable Housing portfolio. To date, the staff costs associated with temporarily serving on the BMAHC are approximately \$15,000. Based on the proposed recommendation for the dissolution of the Corporation and staff time, it is anticipated that costs would be incurred to an upset amount of \$45,000.

Attainable Housing Rental Unit

The Town has also the BMAHC rental unit, and the management and administration of that unit is currently being performed by Town staff.

GBPH notified of 15 opioid overdoses, including one fatal overdose, over past 10 days

Grey Bruce Public Health is advising people who use unregulated street drugs to exercise extreme caution with each dose and follow critical harm reduction recommendations after receiving reports of additional suspected opioid overdoses, including one fatality, in the area.

GBPH has been notified of one fatal and two non-fatal opioid-related poisonings, all in Owen Sound, within the past 48 hours, bringing the total number of suspected overdoses to 15 over the past 10 days. Fourteen of the overdoses were non-fatal.

Pink/blue fentanyl is the substance believed to be responsible for the majority of the overdoses.

GBPH is also observing a concerning trend of crystal meth that appears to be contaminated with opioids. There have been reports of people using presumed meth and exhibiting signs of an opioid overdose, which was then temporarily reversed by naloxone.

"We would like to express our sincere condolences to the loved ones of the individual who died as a result of a recent drug poisoning in our area. Our thoughts are also with those who have been impacted by this recent series of non-fatal overdoses," says Monica Blair, Manager of GBPH's Harm Reduction Program.

"We are encouraging people who use unregulated drugs to use drug test kits in conjunction with other harm reduction strategies. Test kits for fentanyl, benzodiazepines, and xylazine are available from Public Health and several community partners, including Safe 'n Sound, SOS, and the South East Grey Community Health Centre."

GBPH has issued four opioid overdose alerts to community partners since June 1, 2024.

People who use drugs are at significant risk of overdose due to the local street drug supply containing the highly toxic drugs Fentanyl and Fentanyl analogues. Public Health advises that all street drugs should be deemed potentially fatal.

GBPH urges people to have a sober friend with them when using drugs or to call or text the National Overdose Response Service (NORS) or use/download the BRAVE App if using alone. NORS can be reached by calling or texting 1-888-688-6677. A NORS operator will stay on the line with the person while the drug is used. In the event the person becomes unresponsive, NORS will call 911 to ensure help arrives.

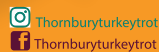
