Water, Tax and other Bills and Payments

Use of Municipal Accommodation Tax and Reserve Fund Policy

The Town of The Blue Mountains has
approved a four percent (4%) Municipal
Accommodation Tax (MAT), which will take
effect on Monday, January 6, 2025. This is a
mandatory tax that must be paid when the
accommodation is paid for.

The tax applies to all overnight stays of
less than 30 days in The Blue Mountains for
transient accommodation. This includes but
is not limited to a hotel, motel, campground,
lodge, inn, resort, bed and breakfast, Short-
Term Rental Accommodation, Commercial
Resort Unit or other establishment providing
lodging.

This is a tax on accommodations only, and
other services such as meeting room rentals,
food and beverage, parking, and room
service are exempt.

Revenue generated by the MAT will be
used to support the local tourism industry.
(estimated at \$4million) This includes
investment in tourism-related infrastructure,
enhanced tourism marketing and promotion,
events and festivals, and tourism product
development.

The initiative aligns TBM with over 70 other
Ontario municipalities that have adopted
similar taxes since 2017 when the province
permitted such measures. The revenue
generated will be split between the town and

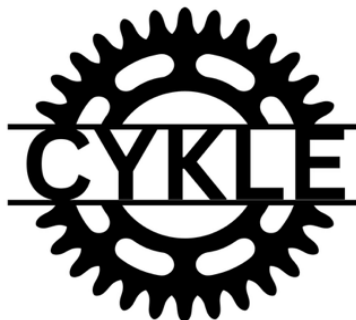

the Blue Mountain Village Association, the
official destination marketing organization
for TBM. This funding aims to boost local
tourism infrastructure and marketing efforts,
potentially increasing visitor numbers and
benefiting local businesses.

The Town of The Blue Mountains will
ensure that funds from the Municipal Portion
of the Municipal Accommodation Tax (MAT)
Program are directed toward tourism-
supportive initiatives and that the funds are
used in an accountable, transparent, and
responsible manner.

The Policy establishes guidelines for
the use of the Municipal Portion of funds
collected through the Town of The Blue
Mountain's MAT program. The fundamental
goal of this policy is to ensure that revenue
collected through the Municipal Portion
of the MAT program is directed to support
and manage Tourism activities, services,
initiatives, and opportunities for residents,
businesses, and visitors to the Town of The
Blue Mountains. The policy also establishes a
Municipal Accommodation Tax Reserve Fund
and sets an appropriate target level for the
balances in the Reserve.

Revenue Sharing

Pursuant to Ontario Regulation 435/17
- Transient Accommodation Tax, 50% of
the revenue, net of administration costs,
collected through the MAT Program in any
given fiscal year will be transferred to the
Eligible Tourism Entity, subject to the terms
and conditions of an agreement entered into
between the Town and the Eligible Tourism
Entity.

Funding Principles

MAT funds within the Reserve may be
utilized in the following manners:

1. Direct Monetary Support (i.e. cash funding
to support a project or initiative); and/or
2. In-Kind Contributions based on the
provision of Town property/facilities,
materials or resources (i.e. staff time) to
support a program or partnership and may
or may not include the provision of cash
funds. (Note: The recovery of costs related to
property/facilities will be based on Council
approved User Fee By-Law.)

Subject to compliance with the Agreement
between the Town and the confirmed
Eligible Tourism Entity, the following are the
basic principles that an initiative or project
must meet and demonstrate in order to be
funded through MAT funds.

- to support investment into tourism-related
infrastructure to help more effectively
manage tourism to the benefit of residents
and visitors;
- to support projects and initiatives that
result in measurable improvements to
Town services that enhance and improve
the management of tourism and visitor
experiences;
- to pursue the goals and implement
recommendations as outlined in the Town's
Tourism and Economic Development
Strategies, as amended from time to time;

- to support the creation of tourism product development to bring new and innovative products, experiences, and services to the Town of The Blue Mountains tourism market;
- to support the promotion of the Town of The Blue Mountains as a leading destination for tourism, leisure and business travel with an emphasis on promoting overnight stays;

Ineligible Funding Programs, projects or initiatives that are considered part of the Town of The Blue Mountains' core business unrelated to tourism and economic development shall not receive funding through the MAT revenue without prior authorization by Council that the funds may be used for a non-tourism-related purpose.

Examples of these are:

a) Salaries Wages and Benefits (with the exception of costs related to In-Kind Contributions as detailed above) b) Operating Costs of Public Works Road Maintenance and Repair

c) Operating Costs of Existing Municipal Facilities Reserve Fund A Municipal Accommodation Tax Reserve Fund shall be established, to which the Municipal Portion of MAT revenue collected shall be deposited. This revenue shall be dispersed at the discretion of Council based on the funding principles of this policy. Interest income earned on the unused actual cash balance within the Reserve is to be held in the Reserve.

Reserve Fund

A Municipal Accommodation Tax Reserve Fund shall be established, to which the Municipal Portion of MAT revenue collected shall be deposited. This revenue shall be dispersed at the discretion of Council based on the funding principles of this policy. Interest income earned on the unused actual cash balance within the Reserve is to be held in the Reserve.

Review Cycle

This Policy will be reviewed once per term of Council by the Senior Management Team for report to Council in open session.

Ontario Cutting Red Tape to Further Reduce Costs for People and Businesses

TORONTO — The Ontario government introduced the Cutting Red Tape, Building Ontario Act, 2024, that if passed, would make life easier and more affordable for businesses and individuals, while improving our competitiveness and strengthening the economy.

The legislation is a key part of the Fall 2024 Red Tape Reduction package that includes such measures as removing barriers to building homes and making it easier for people seeking long-term care. These are among the more than 550 red tape reduction measures introduced since 2018 that have saved people, businesses, not-for-profit organizations, and the broader public sector over \$1 billion every year and 1.5 million hours in time savings.

“Red tape has long hindered productivity and economic growth in Ontario,” said Mike Harris, Minister of Red Tape Reduction. “Thanks to the actions taken by our government since 2018, our red tape reduction measures have lowered costs, improved services and supported economic recovery, all while maintaining essential safety and environmental standards. Our most recent red tape package includes new initiatives that would provide an additional \$20 million in cost savings and more than 56,000 hours in time saved per year. This will continue to make life easier and more affordable, strengthen Ontario’s standing in the global economy and create the conditions for people and businesses to thrive.”

The Cutting Red Tape, Building Ontario Act, 2024 contains over 60 new burden reduction initiatives to improve services, keep costs down and rebuild Ontario’s economy, including:

- Freezing fees for knowledge and road tests for Ontario drivers
- Making the admission process easier for people seeking long-term care
- Reducing unnecessary administrative requirements for brownfield redevelopment to help accelerate the building of new homes
- Speeding up operations at the Landlord and Tenant Board
- Proposing regulatory changes to make it easier for building officials to work across provincial boundaries

- Employing digital tools to help deliver key infrastructure projects such as hospitals, highways and transit on time and on budget

The Ministry of Red Tape Reduction is also proposing to amend the Modernizing Ontario for People and Businesses Act, 2020 to enhance the province’s ability to measure and report on how government’s actions are impacting individuals. This would help identify areas where processes can be simplified and improved so people can spend less time and money accessing or receiving services, resulting in a more positive experience when interacting with government.

As the Ministry of Red Tape Reduction continues its work, people and businesses are encouraged to visit the Red Tape Portal at Ontario.ca/redtape and submit their ideas on ways the province can continue to make it easier to access services and do business in Ontario.

What is being proposed?

The above-captioned applications have been received and deemed complete as of October 16, 2024. This proposal seeks approval to:

- Change the Official Plan designation of the subject lands from Rural, Hazard and Special Agriculture to Community Living Area, Hazard and Special Agriculture with site specific permissions for a maximum density of 39 units/HA resulting in a maximum of 376 rowhouse and back-to-back units;
- Rezone the lands from Rural, Hazard and Special Agriculture to:
 - Introduce 6 sets of site specific and relaxed zoning standards to apply to the corresponding units depending on type;
 - Introduce new standards for back-to-back and rowhouse units;
 - Revise Hazard zone boundaries; and
 - Assign Open Space zoning to proposed park and amenity space
- Subdivide and create lots for each of the proposed 376 rowhouse and back-to-back units and create private roads, a stormwater management facility, park or amenity areas and two hazard land blocks;
- Create a common elements condominium excluding hazard lands;
- Remove significant woodlands from the portion of the lands proposed for development.

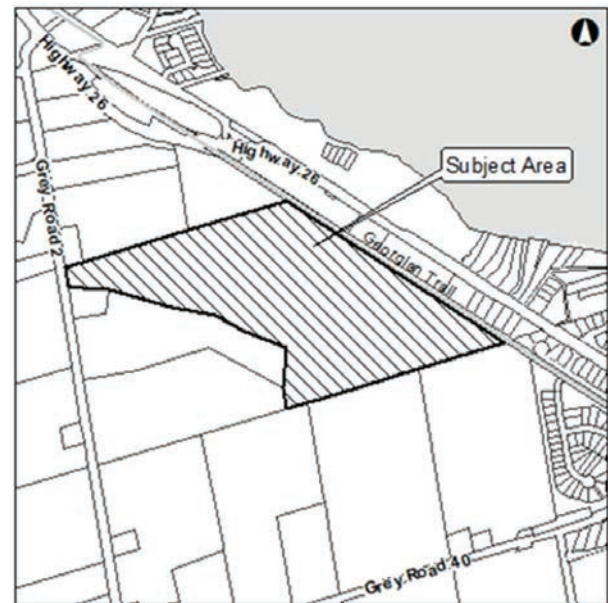
The effect of the proposed Subdivision and Condominium applications would also allow for either or both of a land lease and/or a freehold common element condominium on the subject lands.

Environmental Sustainability Fund Accepting Applications

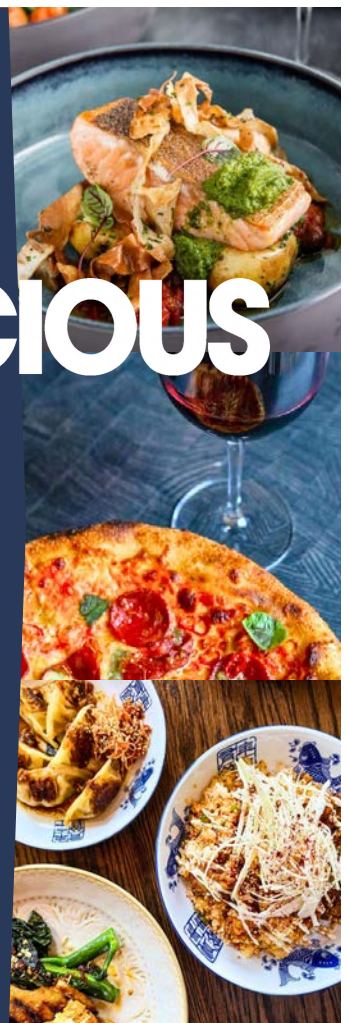
